#### **Statement of intent**

- To raise and support the attainment of students from low income families in receipt of Free School Meals (FSM) or at any point in the last 6 years (referred to as Ever 6 FSM) in order to address any underlying inequalities.
- To provide financial support for students from low income families in receipt of Free School Meals (FSM) or at any point in the last 6 years (referred to as Ever 6 FSM) in order to address any underlying inequalities.
- To ensure students are not disadvantaged in any way in school due to financial constraints.
- To provide pastoral support for students from service families

#### **Challenges**

This details the key challenges to achievement that we have identified among our disadvantaged students.

Challenge

Attainment	Our tracking suggest that PPG students continue to perform in line with their peers. Tracking is individually based as the group is too small to analyse in a statistically meaningful way.
Mental Health	Our assessments, observations and discussions with students and families have identified social and emotional issues for some students, such as anxiety, depression and low self-esteem.
	While the long-term effects of the pandemic can still be seen in terms of anxiety, depression etc, the number of referrals to counsellors has dropped significantly over time. In 2021/22, there were 116 referrals and this reduced to 67 in 2022/23, suggesting that the impact of the pandemic may now have lessened slightly. Out of 35 students who saw the School Nurse in 2022/23, 2 were PP students. Out of 84 students who saw a counsellor, 4 were PP/bursary students.
Attendance	For 2022/23, from Years 7 to 10 inclusive, out of 36 PP students, 6 (16%) had an attendance rate of less than 90%. For non-PP students, out of 428 students from Years 7 to 10, 35 (8%) had less than 90% attendance. Of the 6 PP students with less than 90% attendance, one missed school due to a planned operation, one had unauthorised travel abroad and one had time off for religious reasons. I have not included data for Year 11 students as the Study Leave code skews the data. The overall attendance rate (Terms 1 to 5 inclusive so that the Year 11 Study Leave code in Year 6 does not skew the results) was 91.74% for PP students and 91.65% for non-PP students. This is for Years 7 to 13 as the whole school data for last year does not allow excluding the Sixth Form students. Attendance Support Plans were in place for all students with less than 90% attendance, where appropriate.
