## Kendrick School

### Pupil Premium Policy

#### **Introduction**

The Pupil Premium is additional funding which is allocated to schools on the basis of the number of pupils who have been eligible for free school meals (FSM) at any point over the last six years (known as 'Ever 6 FSM').

The Pupil Premium is aimed at addressing the current underlying inequalities that exist between children from disadvantaged backgrounds and their more affluent peers.

The Pupil Premium Funding grant is targeted at:

- raising the attainment of disadvantaged pupils of all abilities to reach their potential
- supporting children and young people with parents in the regular armed forces

#### **Purpose**

As a Trust in receipt of Pupil Premium funding, Kendrick School is accountable for how this additional funding is used to narrow the achievement gap of its students. Under The School Information (England) (Amendment) Regulations 2012, Schedule 4 specified information must be published on the Kendrick School's website.

Under Section 9 of the regulation the school will publish:

- The amount of the school's allocation from the Pupil Premium grant in respect of the current academic year
- Details of how it is intended that the allocation will be spent
- Details of how the previous academic year's allocation was spent
- The effect of the expenditure on the educational attainment of those students at the school in respect of whom the grant funding was allocated'

In meeting this requirement and in accordance with the Data Protection Act 1998, no students or groups of students, including students funded through the Service Premium, will be identified.

#### **Pupil Premium Objectives**

The DfE has given all schools and academies the freedom to use the Pupil Premium as they see fit, based upon their knowledge of student needs, the context of the school and the academic abilities of its students.

Kendrick School is accountable for the use of this additional funding. The criteria for Pupil Premium expenditure will be based as follows:

- Ensure that Pupil Premium funding allocated is used solely for its intended purpose.
- Use the latest evidence based research on proven strategies which work to narrow the attainment gap and adapt these as necessary to meet the needs of the students.
- Ensure transparency so that parents, interested stakeholders and Ofsted are fully aware of how this additional resource has been used to make a difference.

- Encourage take up of FSM by working proactively with parents and carers in a sensitive and supportive manner and to remove any potential barriers or stigma attached to claiming FSM.
- Ensure there is awareness and robust monitoring and tracking of performance and attainment in place of every student receiving of the Pupil Premium
- Ensure there is robust monitoring and evaluation in place to account for the use of the Pupil Premium.
- Use high quality teaching and learning as the preferred way to prevent any gap in attainment whilst also recognising the importance of developing the whole child through identifying and intervening with their social and emotional development where necessary.
- Use the Pupil Premium to provide teaching and learning resources, educational and curriculum enrichment opportunities and financial assistance as required.
- Address Pupil Premium issues at all key senior, department and pastoral leadership meetings.

**The current criteria for claiming Free School Meals (FSM) are:**

- family receives Income Support or Income-Based Job Seekers Allowance. Please note, Contribution-Based Job Seeker's Allowance does not qualify for free school meals (unless you receive both Income-based & Contribution-based JSA on an equal basis);
- family receives the Guarantee element of State Pension Credit;
- family receives Child Tax Credit and has an annual income, as assessed by HMRC, not in excess of £16,190. Please note, families who are also entitled to Working Tax Credit do not qualify to claim free school meals regardless of income;
- Support under part VI of the Immigration and Asylum Act 1999;
- Employment and Support Allowance (Income Related). Please note, Contribution-Based E&SA does not qualify for free school meals (unless you receive both Income-based & Contribution-based ESA on an equal basis).

An online checking system may be used but this will only confirm or deny an eligibility to claim free school meals: it does not provide any additional other information.

Once eligibility has been confirmed and the application processed, an email confirming eligibility will be sent. The school will also receive notification of a child's application.

The online checking system will continuously check eligibility status and inform the family and the school of any changes

Parents/carers are encouraged to contact the school if they have any queries or questions about the process.

**Pupil Premium Allocation and Expenditure Strategy**

Pupil Premium funding allocation is clearly identified in the school budget plan. Expenditure priorities include:

- Provide effective 1:1 Tuition and/or small group interventions.
- Provide transport, uniform and educational resources subsidies directly to the families.
- Provide subsidised financial support for visits to support teaching and learning and engagement with the school curriculum and community.
- Provide subsidised financial support for whole year group residential trips for social development and provide new experiences and enrichment.

- Subsidise free school meal contract.
- Provide counselling and outside agency interventions to support emotional well-being and attendance.
- Provide subsidised financial support for IT equipment, licences and educational resources to enhance the learning opportunities in school
- Dyslexia screening.
- Staffing for strategy development and student performance monitoring discussions.
- If funding allows to provide subsidies for personal and educational development of students outside of school.

## **Roles and Responsibilities**

Kendrick School expects all staff and trustees to be committed to raising standards and narrowing the attainment gap of all students through leadership, inspiration and making a difference in students' lives.

### **Senior Leadership Team (SLT)**

The Headteacher and SLT are responsible for implementing this policy by ensuring that all staff are aware of their responsibilities in narrowing the gap of student attainment and providing appropriate support and relevant professional development opportunities to accelerate students' progress and attainment.

It will be the responsibility of the Headteacher to submit an annual report to the Board of Trustees outlining the allocation, spending and impact on students and their achievements.

### **Teaching and Support Staff will:**

- maintain the highest expectations of all students thereby promoting an inclusive and collaborative ethos in school and enabling all students to thrive irrespective of socioeconomic circumstances
- plan and deliver curricular and lessons to a high standard and support the acceleration of progress in learning, so that attainment gaps can be avoided or narrowed and improvements maintained.
- support disadvantaged groups of students through differentiated planning and teaching
- keep up-to-date with teaching strategies and research, which have proven track record in narrowing the gaps in attainment and achievement.

Kendrick School provides opportunities for staff to engage in a range of professional development opportunities suited to their particular needs and role, to enable the implementation of successful strategies in order to accelerate student progress and narrow the attainment gap.

### **The Board of Trustees**

The Board of Trustees will ensure that the legislation, the policy and the specific stated actions for narrowing the attainment gaps are implemented.

The Board of Trustees will ensure that there is an annual statement on how the Pupil Premium funding has been used to address the issue of narrowing the attainment gap and the impact this has had, in line with The School Information (England) (Amendment) Regulations 2012, Schedule 4, Section 9.

## **Monitoring and Reviewing**

Work in relation to the Pupil Premium will be reviewed on a termly basis to ensure it is having the intended impact and to provide an opportunity to make adjustments and intervene quickly.

The Pupil Premium Policy will be reviewed on an annual basis and adjusted to maximise the impact and benefits to the students having taken into consideration any changes in funding under the Pupil Premium Grant.

Kendrick School and the Board of Trustees recognise the importance of context and will evaluate new strategies to ensure any new approaches have the desired outcomes for its students.
